

SUMMIT 2025 Sponsorship Agreement

This Sponsorship Agreement (this “**Agreement**”) is effective as of _____, by and between PointClickCare Technologies Inc. (“**PointClickCare**”) and the undersigned sponsor (“**Sponsor**”) for the 2025 PointClickCare SUMMIT event (“**SUMMIT**”). Exhibit A to this Agreement, which is incorporated herein and made part of this Agreement, outlines the benefits Sponsors receive based on their selected Package as well as the early bird sponsorship fees Sponsors may be eligible for by entering into this Agreement in accordance with the terms and conditions below.

1. Sponsor’s Responsibilities

1.1 Commitment. Sponsors must return an executed Agreement to PointClickCare by no later than January 16, 2025, indicating their choice of package from the options below and making the payments within the timeframes outlined in this Agreement.

1.2 Payment of Deposit. Upon receipt of the executed Agreement, PointClickCare shall invoice Sponsor for the Sponsor’s selected Package. Sponsor agrees to pay a \$3,000 USD non-refundable deposit within 30 days from the invoice date. By paying the deposit, Sponsor ensures its reservation of the Package and spot (“**Reservation**”). Sponsor agrees to make payments by credit card, automated clearinghouse or other form of electronic payment acceptable to PointClickCare. In the event Sponsor fails to pay the required deposit within the specified timeframe, PointClickCare reserves the right to cancel the Reservation without further notice and release the Sponsor’s spot to another party.

1.3 Complete Payment. Sponsor agrees to pay the balance of the Sponsorship fee (“**Complete Sponsorship Fee**”) by no later than February 3, 2025 (“**Expiration Date**”). It is the responsibility of the Sponsor to ensure that payment is made before the Expiration Date. In the event Sponsor fails to pay the Complete Sponsorship Fee prior to the Expiration Date, the Sponsor will forfeit its non-refundable deposit and will no longer be eligible for the early bird sponsorship fee and PointClickCare reserves the right to release the Sponsor’s spot to another party without further notice. Sponsors who terminate this Agreement in writing by providing written notice of such termination addressed to summitsponsor@pointclickcare.com on or before February 3, 2025 will receive a refund subject to a deduction of the non-refundable deposit to cover administrative costs and processing fees incurred by PointClickCare. No refunds will be issued after February 3, 2025.

2. General Provisions

2.1 Assignment. Sponsor shall not assign its rights or obligations under this Agreement, voluntarily, involuntarily, by operation or law or otherwise, without PointClickCare’s prior written consent. Any attempt by Sponsor to assign its rights or obligations under this Agreement in breach of this section is void and of no effect.

2.2 Additional Terms. Sponsor acknowledges and agrees that Sponsor may be subject to additional terms or conditions regarding attendance of the SUMMIT by or before the time of the SUMMIT.

2.3 Force Majeure. In the event PointClickCare is unable to hold the SUMMIT due to circumstances beyond its control, including but not limited to fire, disaster, explosion, adverse weather conditions, labor disputes or disruptions, epidemics, pandemics, wars, national emergencies, civil disturbances, shortages of materials, actions or inactions of government authorities, terrorist acts: PointClickCare agrees to provide a full refund of any fees or payments made by the Sponsor. The refund shall be issued within 90 days from the date of cancellation. PointClickCare shall not be liable for any additional costs or damages incurred by the Sponsor as a result of the SUMMIT cancellation.

2.4 Counterparts. This Agreement may be executed in one or more counterparts, including by way of .pdf or other electronic means (such as DocuSign or Adobe eSign), each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
